Mr. Billeck has litigated business disputes involving antitrust, shareholder claims, securities violations, theft of trade secrets/non-competes, insurance claims, breach of contract and fiduciary duty, negligence, fraud, class actions, product defects, and bankruptcy matters such as confirmation of plans of reorganization, adversary proceedings and avoidance actions, and contested matters. Mr. Billeck's experience has spanned a wide range of industries, such as energy, including oil and gas, telecom and technology, complex financial products, insurance, gaming, automotive, healthcare, maritime, assisted living facilities, agriculture products, professional service companies, and many others. He has recovered millions of dollars for plaintiffs, obtained summary judgment or dismissal of numerous cases, and successfully resolved many matters on behalf of defendants for cents on the dollar.

Mr. Billeck has directed all aspects of complex litigation, including pre-suit investigation and analysis, discovery, mediation and settlement negotiations, advising clients on litigation strategy, significant hearings, and serving as trial and appellate counsel in cases ranging from small commercial disputes to bet the company litigation. He graduated *Magna Cum Laude* from University of Houston Law Center, earning Order of Coif honors.
